## Persuasive Writing with the DARE Writing Strategy and the CO:Writer Universal App

CO:Writer Universal is a technology app with word prediction, talking word processor, and customizable vocabulary banks. The DARE writing strategy is used frequently with the SRSD model by Graham and Harris. Teacher Josh Stock shows how his middle school students take the brainstorming STOP strategy to write an essay using DARE within the CO:Writer app.

The DARE Strategy has four elements: **D**evelop a Claim, **A**dd Supporting Ideas, **R**eject the Other Side, **E**nd with a Conclusion.

The first step in DARE is to **develop a claim**. The claim is a clear topic sentence of which side of an argument the student chooses. The claim is the foundation of the essay.

The A in DARE reminds students to **add supporting ideas** or details. These ideas were generated in a list from the STOP strategy. The ideas must always link back directly to the claim.

R means to **reject the other side**, by showing evidence that the opposing argument is wrong. Teacher Josh Stock provides a sentence structure, “Some people say \_\_\_\_\_. However, \_\_\_\_\_” to help his students when they first start out opposing and refuting the other side of an argument.

**End with a conclusion** means to end with writing a sentence that restates the claim or, to go further, has a call-to-action. The student tells the reader what to do next.

After students have done the DARE analysis, then they are ready to write. Teachers may have them simply write a paragraph or for more advanced writing, a 5-paragraph essay with each of the supporting ideas within their own paragraph. Writing within CO:Writer gives the students access to word prediction, a talking word processor, and vocabulary word banks.

DARE gives students a great structure for their persuasive writing within CO:Writer Universal.

# Strategies for Effective Writing: STOP + DARE



## Persuasive Planning and Writing with STOP + DARE

### STEP 1. STOP

**Suspend judgment.** Consider both sides of an issue before taking a position.

**Take a side.** Write down ideas for both sides.

**Organize ideas.** Select ideas on the “for” or “against” side that best support your position.

**Plan more and say more as you write.**

Continue planning while writing. Add more ideas.

### STEP 2. DARE

**Develop your topic/thesis sentence.**

**Add supporting ideas.**

**Reject arguments for the other side.**

**End with a strong conclusion.**

## What is Co:Writer Universal?

Co:Writer Universal is a set of writing tools that aides with phonetic spelling, grammar, and topic-related vocabulary. The tools can be used with many different computing devices in a consistent and reliable way.

## Why do I need to login to use Co:Writer Universal?

Co:Writer Universal will automatically save display settings and topic vocabulary anywhere you use Co:Writer to write. In addition, if you are writing within an iOS device or Google Chrome Applications, Co:Writer will save your document automatically.

## Options and Settings:

Co:Writer allows you adjust speech and display options. It will also allow you to supply topic specific vocabulary as well as personal words like family and pet names.

## Speech Options:

Co:Writer has tools available to adjust voice, volume, pitch and rate for text to speech. These settings are device specific.

## Word Prediction Options:

You can now adjust font, background and foreground colors, size and number of guesses for prediction box. Co:Writer also allows you to adjust the font size, background and foreground colors for writing environments within the iOS and Google Apps.



## Co:Writer writing environment::

When writing with Co:Writer within the Chrome or iOS applications, your writings will be saved automatically, and can be accessed from any Co:Writer enabled device with an internet connection.

## Home Page:



Click on trash to select writings to be removed.



Click on export to export to places like Dropbox or Google Drive.

## New

Click on the word “New” to create a new writing. Otherwise, click on a writing you have already started to continue to write.
